Partially Recommended: Diagnoser provides many computer-based assessments, many of which align to GLEs. The items often have graphics and pictures, and are written in clear and concise language. However, we only partially recommend these assessments due to their limited ability to assess students' higher level thinking and skills with regard to GLEs. It is recommended that these items be used only for purposes of assessing students' basic knowledge of content, but the use of more performance-based assessments is needed to show students' abilities with regard to the higher level skills under the GLEs (designing investigations, gathering evidence, evaluating evidence, etc.).
