These alternate modes of access are auditory, multi-sensory, tactile, and visual.  Description Response Accommodations — Allow students to complete activities, assignments, and assessments in different ways or to solve or organize problems using some type of assistive device or organizer.  Description Setting Accommodations — Change the location in which a test or assignment is given or the conditions of the assessment setting.  Description Timing and Scheduling Accommodations — Increase the allowable length of time to complete an assessment or assignment and perhaps change the way the time is organized.
